CHRISTOPH DONNER CHIEF EXECUTIVE OFFICER, AMERICA PIMCO PRIME REAL ESTATE LLC

Mr. Donner is the chief executive officer, United States, of PIMCO Prime Real Estate (formerly Allianz Real Estate). Previously, he was senior managing director and chief credit officer at Aareal Capital Corporation in New York.

Mr. Donner has also worked as managing director at Hypo Real Estate in New York and Munich, as head of project finance at Vivico Real Estate in Frankfurt, and as a vice president at Deutsche Bank in Frankfurt.

He has 25 years of real estate experience and holds a graduate degree in business from the Technische Universität in Berlin.

SENATOR BILL HAGERTY (R-TN) RANKING MEMBER

SUBCOMMITTEE ON NATIONAL SECURITY AND INTERNATIONAL TRADE AND FINANCE SENATE BANKING COMMITTEE

United States Senator Bill Hagerty was elected to the U.S. Senate in 2020 and is currently serving his first term representing the state of Tennessee. His committee assignments include: U.S. Senate Committee on Banking, Housing, & Urban Affairs; U.S. Senate Committee on Foreign Relations; U.S. Senate Committee on Appropriations; and the U.S. Senate Committee on Rules & Administration. Prior to his election to the U.S. Senate, Hagerty served as the U.S. Ambassador to Japan, the world's third largest economy and America's closest ally in the region.

Hagerty is a life-long businessman. He started his business career with the Boston Consulting Group, where his work took him to five continents, including three years based in Tokyo, Japan. He later became a venture capital and private equity investor where he invested in and served as an executive and board member of a wide range of companies, including ones listed on the New York Stock Exchange and NASDAQ. From 2011 to 2014, Hagerty took leave from his business career to serve as a member of the Governor's Cabinet and Commissioner of the Tennessee Department of Economic and Community Development. During his tenure as commissioner, Hagerty reorganized the department, eliminating over 40 percent of the positions and saving millions of taxpayer dollars. At the same time, the new approach helped spur the strongest economic transformation seen — taking Tennessee from an unemployment rate higher than the national average when he arrived to become the number one state in the nation for jobs created through foreign investment and being named State of the Year for Economic Development an unprecedented two years in a row during his tenure.

Hagerty, an Eagle Scout, is originally from Sumner County, Tennessee. Today, he and his wife Chrissy are both active volunteers in several community and civic organizations, and live in Davidson County, Tennessee. They are the parents of four children. one of his key assignments was representing the United States as a negotiator in the historic bilateral talks with Japan known as the Structural Impediments Initiative (SII).

SARAH HAWKINS CEO, EAST REGION / NEW YORK, NY HINES

Sarah is the CEO of Hines' East Region, overseeing development, acquisition, asset management, and operations activities across offices in New York City, Boston, Washington, D.C., and Philadelphia, with \$20 billion in assets under management. She is a member of the firm's global Executive Committee.

Sarah joined Hines in 2011 as Assistant Project Manager for the 7 Bryant Park office development and has since spearheaded the region's expansion into senior housing and industrial platforms, expanded the residential business, and opened the Philadelphia office.

She has been recognized in Commercial Observer's Power 100 feature and Crain's New York's "2021 Notables in Real Estate" list. She serves on the board of Vertex Partnership Academies and the Executive Council for the University of Texas Real Estate Center. Sarah earned her Bachelor of Arts and Bachelor of Business Administration degrees from The University of Texas, where she graduated Phi Beta Kappa.

Chris Ludeman is Global President of Capital Markets for CBRE. CBRE is the world's leading commercial real estate services firm and ranked at #126 on Fortune's 2022 list of the largest U.S.-based public companies. The firm spans more than 100 countries and nearly 100,000 employees.

Chris drives the company's advisory business for investors, including responsibility for equity sales, debt and structured finance and real estate investment banking, both globally and in the Americas. In 2021, the company was the intermediary for \$450 billion in capital markets engagements, including \$90 billion in debt financing. He serves as a member of the Global Operating Committee and the Americas Operations ManagementBoard.
