Senior Policy Advisor House Speaker Mike Johnson (R-LA)

Curt Beaulieu currently serves as Senior Policy Advisor for House Speaker Mike Johnson (R-LA), where he focuses on tax issues. Most recently, Mr. Beaulieu was a Senior Director at Boeing, and prior to that, a Senior Counsel at Bracewell in Washington, DC. Curt returned to the Hill earlier this year and comes with over a decade of experience in tax policy on both sides of the Capitol. He previously served as tax counsel for Ways and Means Committee Ranking Member Jim McCrery (R-LA) and Senate Finance Committee Chairman Orrin Hatch (R-UT). Mr. Beaulieu earned his JD at California Western School of Law and his LLM at Georgetown University.
